The Waynesboro Electoral Board March 4, 2020 Canvass Meeting for the March 3, 2020 Democratic Primary Election.

The Chair moved that the Electoral Board of Waynesboro convene in closed session pursuant to 24.2-563 of the Code of Virginia for the purpose of considering whether each person who submitted a provisional vote at the election was qualified to do so, and the general registrar and any authorized representatives of candidates or political parties, as specified in 24.2-653 (B), be allowed to remain in the room during the closed meeting, and that any persons who cast provisional votes and who are present be allowed to enter the room while their qualifications are considered and to present any relevant information on their behalf to the board. The Vice Chair seconded the motion and the Board unanimously approved the motion. The Board went into session.

At 9:38a, Chair Elizabeth Bouldin-Clopton moved to reconvene in open session and that the Electoral Board of Waynesboro that the closed session just concluded that the only matters discussed were the qualifications of provisional voters, as directed by 24.2-653 of the Code of Virginia, and as identified in the motion to close the meeting pursuant to the Virginia Freedom of information. The motion was seconded by the Vice Chair and unanimously approved by the Board.

The board moved out of Closed Provisional Session having conducted the Provisional Assessment and applicable exemption from subsection of 2.2-3711 to an open meeting.

These issues will be addressed at the Chief and Assistant Chief Debriefing and training session prior to the May election.

The final results of the Democratic Presidential Primary:

Joseph Biden won the Primary.

2,746 votes were cast out of 13,677 registered Waynesboro voters.

20% of the registered voters voted an increase over the 2016 Democratic Primary voters.
