#### **TAXES FOR CALENDAR YEAR 2020:**

At the May 7, 2020 Council meeting, the ordinance imposing taxes for the calendar year 2020 on property and persons, for the payment of interest on the city debt, for the support of the city government, for the maintenance of the public schools, and for other expenses, providing for the assessment of persons and property, for the collection of taxes, revenue, assessments, and imposing penalties for the failure to comply with the provisions hereof was introduced and seconded. With no further discussion of the ordinance, it was adopted on a 5:0 vote:

#### **FISCAL YEAR 2021 OPERATING BUDGET:**

At the May 7, 2020 Council meeting, Council introduced and seconded the Annual Appropriation Bill for the year ending June 30, 2021 after the public hearing was held on the matter. Council is now asked to consider adopting a friendly amendment to incorporate changes that the School Board adopted to their budget. The total value of the budget decreases by approximately \$1.1 million reflecting changes in the local and state funding for the schools. There are no changes to the municipal portion of the budget. The City Manager stated that if conditions improve, Council will be asked to consider favorable amendments to the budget. If conditions don't improve or worsen, it may be necessary for Council to consider additional reductions to the budget. Those possibilities may not be apparent until the second quarter of the fiscal year.

Vice Mayor Henderson made a friendly amendment to the budget by incorporating the Waynesboro School budget amendment into the City Budget. Council member McCutcheon, having introduced the budget ordinance, accepted the friendly amendment. Having been seconded and with no objections, the friendly amendment was adopted into the Annual Appropriation Bill ordinance on a 5:0 vote:

## **RESOLUTION – CORONAVIRUS RELIEF FUND PAYMENT:**

The City is eligible to receive \$1,974,380 through the federal Coronavirus Aid Relief and Economic Security Act (CARES ACT). Payments from the fund may only be used to cover costs that are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus of 2019 and cannot be used to cover revenue shortfall. The expenditures must occur between March 1, 2020 and December 30, 2020.

The City is required to transmit certification to the Commonwealth by May 22, 2020 at which time the funds would be transferred to the City. Any unspent funds would be returned.

Council member Allen moved to endorse the certification. Having been seconded and with no objections, the motion was adopted on a 5:0 vote:
